Under Clause 31A of the Registered Clubs Regulation, a person must not stand for election as a member of the governing body of a registered club unless the person discloses any previous period in which the person was declared by the Independent Liquor and Gaming Authority under section 57H (2) (g) of the Act to be ineligible to stand for election or to be appointed to, or to hold office in, the position of secretary or member of the governing body of that club or any other registered club.

Such disclosure must be made during the nomination period and is to be clearly displayed on a noticeboard on the premises of the registered club and on the club's website (if any) for at least 7 days before the person stands for election.
